# 1. Legal Framework

## LEGAL BASIS

- Based on **Austrian Federal Act on Protection Against Domestic Violence**
  - entered into force **1 May 1997**
  - several amendments since, most important improvements in 2009 and 2013
  - is a **bundle of newly adopted or amended provisions** covering
    - a. **protection by the police** (e.g. barring orders against perpetrators)
    - b. **protection under civil law** (e.g. temporary injunctions)
    - c. sanctions for the perpetrator under **criminal law**
    - d. **victims' rights** in criminal and civil law proceedings



## a. Protection by the Police

### EMERGENCY BARRING ORDERS

- **immediate eviction** of a dangerous person **by the police** from a house or an apartment
- evicted person is not allowed to return for **14 days**
- **ownership** of the house or apartment is **irrelevant**
- protection for all individuals at danger of becoming victims of violence by the perpetrator (spouse, children, house-mates,...)
- if **children under 14** are affected by violence, barring orders can also extend to schools and other childcare institutions
- **purpose** is to allow for victims of violence to stay there safely, while the aggressor is removed

#### Precondition

- **(imminent) dangerous attack** to life, health or freedom of a person (preventive approach) → some form of danger assessment is necessary



## b. Protection under Civil Law

### TEMPORARY INJUNCTIONS

- **long-term protection** (up to 6 months/ one year)
- can be applied for within the two weeks of an effective barring order
- can also be applied for without prior police intervention
- **Different types of temporary injunctions**
  1. protection in the **sphere of living** (house/apartment and surroundings) – ownership irrelevant!
  2. other **places the victim routinely visits** (e.g. work place, school,...)
  3. **no-contact order**
  4. **anti-stalking** temporary injunction



# c. Criminal Law

## **VIOLENT ACTS INCLUDED IN THE AUSTRIAN PENAL CODE**

- bodily harm and grievous bodily harm (§83 and § 84)
- maliciously inflicted grievous bodily harm (§§ 87)
- deprivation of liberty (§ 99)
- coercion and grievous coercion (§§ 105 and 106)
- dangerous threats (§ 107)
- insistent persecution (= stalking) (§ 107a)
- continued exercise of violence (§ 107b)
- rape (§ 201)
- sexual coercion (§ 202)
- violating a person's sexual self-determination (§205a)
- grievous sexual abuse and sexual abuse against minors (§§ 206 and 207).



## c. Criminal Law

### VIOLENT ACTS cont.

- subject to public prosecution
- charges are brought and perpetrators are prosecuted by the State as soon as the facts become known to the authorities (police, courts)
- approval of the victim is not required



## 2. Victims' support through specialized organizations

- In cases of domestic violence (or stalking) → specialized victims' support organization (**Violence Protection Centers/ Intervention Center**) must be informed by the police
- Precondition: An **emergency barring** order has been issued by the police or the offence of stalking has been reported
- **Notification** of Violence Protection Center/ Intervention Center is **mandatory**, approval by the victim is not required



# Violence Protection Centers/ Intervention Center

## STRUCTURE

- one in each of the 9 Austrian provinces
- provided for by law (Austrian Federal Act on Protection Against Domestic Violence)
- 100% funded by relevant ministries
- non-profit associations
- employees: social workers, legal professionals
- work in close collaboration with the police





# Violence Protection Centers/ Intervention Center – cont.

## WORKING METHODS AND PRINCIPLES

- pro-active approach – victims are contacted after referral of the case by the police
- offer of support is voluntary, confidential and free of charge
- support is gender-sensitive, feminist, advocacy-based (i.e. „on the victims’ side“)



# Violence Protection Centers/ Intervention Center – cont.

## SERVICES PROVIDED

- **psycho-social support and counselling** (e.g. processing experiences, deciding on whether to leave the abusive partner, financial issues, housing, ...)
- **legal counselling**, e.g. assistance with applying for a temporary injunction against the perpetrator („prolongation“ of police-issued barring orders)
- **„court assistance“**
  - criminal proceedings → psycho-social and legal
  - civil law proceedings (when related to a criminal proceeding for which court assistance is provided) → only psycho-social
- safety planning and **danger assessment** → alert police/ public prosecutor's office in high risk cases




