Subject: COVID-19. Oxford-Astrazeneca vaccine. Delivery schedule of 02 million doses of vaccines to Brazil.

Mr. CEO of AstraZeneca,

1. As I greet you cordially, I refer to your meeting with the Brazilian Minister of Health, Eduardo Pazuello, on December 29, 2020, for which we are very grateful.
2. On this occasion, I reaffirm AstraZeneca's credibility, materialized with Brazil through the partnership between Fiocruz and AstraZeneca.
3. I am also grateful for the offer and additional availability to Brazil of 02 (two) million doses of finalized vaccines, still in January 2021. These doses will make it possible to start the immunization of the Brazilian population, in compliance with the National Plan for the Operationalization of the Vaccination against Covid-19.
4. Considering the challenges for the operationalization of the vaccination in a country with dimensions and specificities such as Brazil, we need to plan and anticipate the needs in logistics and execution of the vaccination campaign necessary to execute the Vaccination Plan.
5. From the above, we would kindly request information on the price and delivery schedule of the referred 2 million vaccine doses in Brazil, specifying the measures, weight, cubage, location and expected dates for each delivery, as well as refrigeration and other special conditions for transportation.
