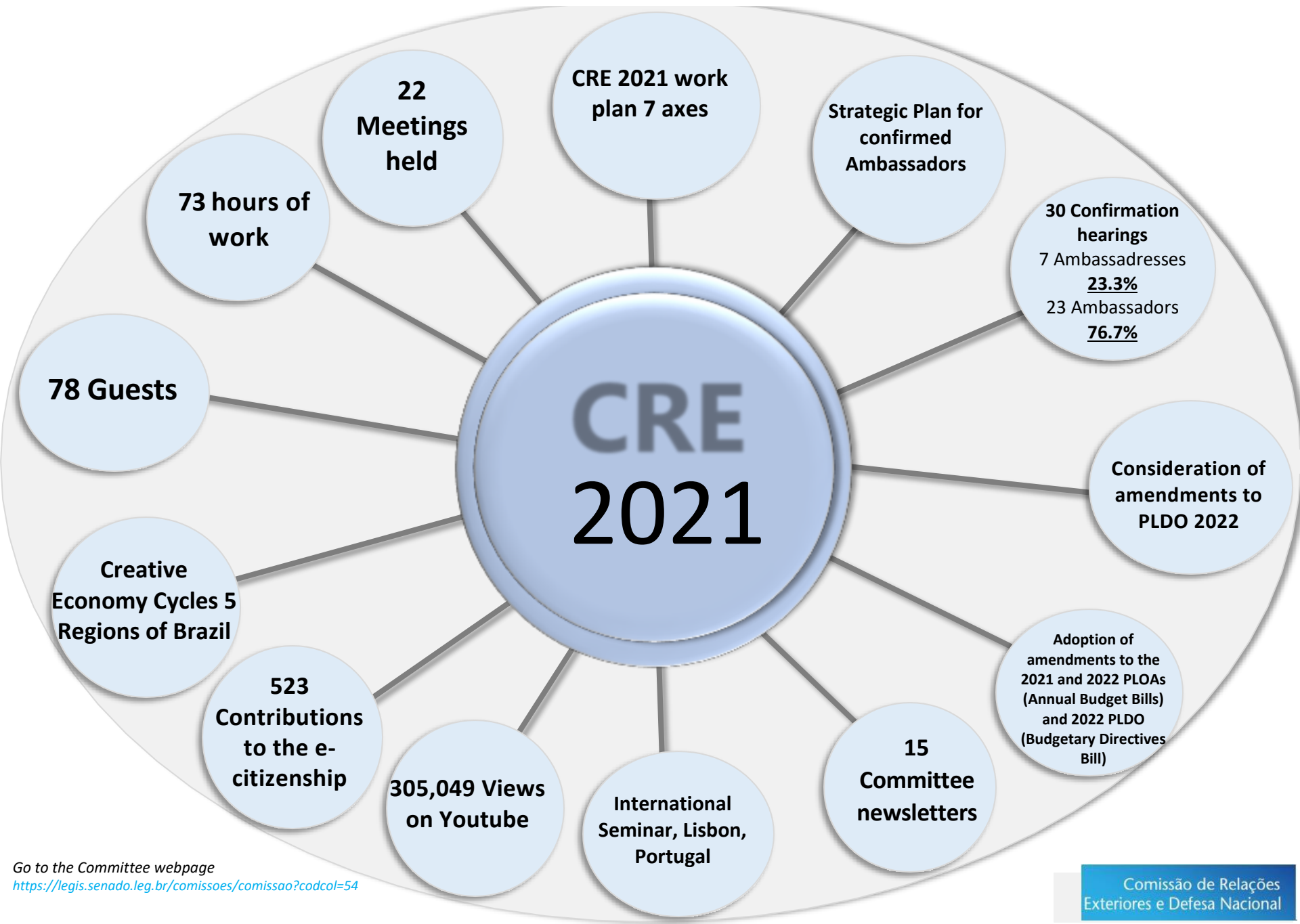

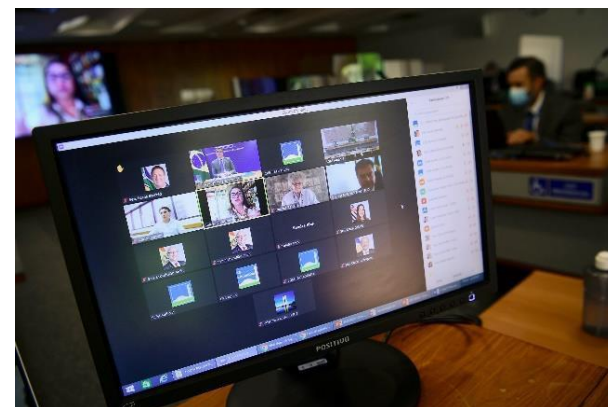

BILL OF LEGISLATIVE DECREE LEGISLATIVO no. 255, OF 2021 - Adopts the text of the Convention on Cyber Crime, concluded in Budapest on 23 November 2001.

BILL OF LAW no. 6039, OF 2019 – Amends Law nº 5.662, of June 21, 1971, to establish parameters for foreign countries to obtain credit from the National Bank for Economic and Social Development – BNDES.

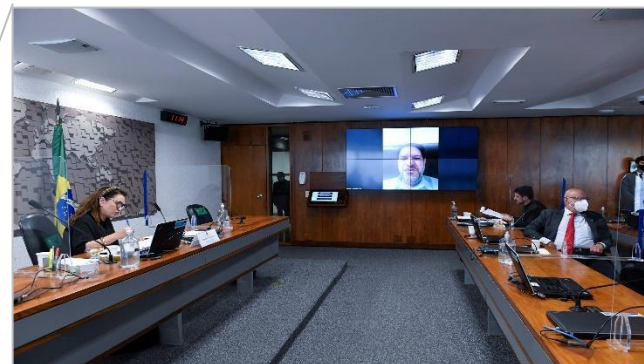
CHAMBER BILL OF LAW no. 10, DE 2017 - Repeals item VII of article 106 of Law no. 6,815, of August 19, 1980 – Foreigner Statute.

SENATE BILL OF LAW no. 371, OF 2017 – Amends Law no. 11,473, of May 10, 2007, to provide for the possibility of the majority of the group of federal deputies and senators elected by the State that faces a serious situation of preservation of public order and threat to the safety of people and property to request directly to the Union federative cooperation for public security.

BILL OF LAW no. 5010, OF 2020 – Amends Law nº 11.279, February 9, 2006, to include courses in the Naval Education System (SEN), to adjust the age range for entry into Navy bodies and cadres, and to establish restrictions on the use of tattoos.

BILL OF LAW no. 557, OF 2019 - Amends Law no. 4.375, August 17, 1964, which provides for Military Service, to prioritize young graduates of host institutions in the selection.
