Comunico, nos termos do art. 39, I, do Regimento Interno do Senado Federal, que estarei ausente do País de 16/09/2025 a 21/09/2025, para desempenho desta missão.

JUSTIFICAÇÃO

Há dados incongruentes sobre a balança comercial brasileira no momento atual. Enquanto a Associação de Comércio Exterior do Brasil (AEB) projeta uma queda de 27,4% no superávit em relação a 2024, com um aumento nas importações; o Ministério do Desenvolvimento, Indústria, Comércio e Serviços (MDIC) informa um superávit de US\$ 7,1 bilhões em julho, com crescimento nas exportações e importações. Num ambiente extremamente incerto



para os mercados no mundo e a aceleração do fenômeno do comércio digital, é fundamental a participação dos Paramentos nas discussões sobre esses temas.

A minha participação no Fórum Público da OMC, enquanto representante do Parlamento Brasileiro junto à UIP, trará não apenas maior credibilidade em relação ao desejo do Congresso Brasileiro em contribuir para a solução de problemas concernentes ao comércio mundial, como também enriquecerá os debates internos na Casa, principalmente na Comissão de Assuntos Econômicos, da qual sou integrante.
