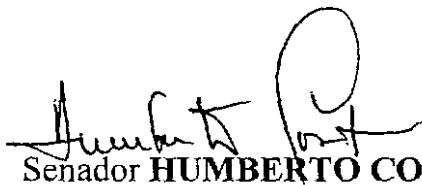

On behalf of the Global Organization of Parliamentarians Against Corruption (GOPAC), I am pleased to invite you to the ***Fifth Forum of Parliamentarians in Panama City, Panama, 27 November 2013.***

The Forum aims to engage parliamentarians on their role in holding governments accountable to the implementation of the United Nations Convention Against Corruption (UNCAC), ratified in over 165 countries from every region in the world.

GOPAC will also launch its latest handbook, *Improving Democratic Accountability Globally: A Handbook for Legislators on Congressional Oversight in Presidential Systems*— a ground-breaking reference that aims to guide legislators in strengthening their congressional oversight functions.

At the request of the United Nations Office of Drugs and Crime (UNODC), the Forum will be held in parallel with the Fifth Conference of States Parties to the United Nations Convention Against Corruption (5th CoSP-UNCAC), to be convened also in Panama City from November 25 to 29, 2013.

Please note that the UNODC letter of invitation for the 5th CoSP-UNCAC provides for “policy makers” to be included in the delegation. We encourage all GOPAC members to request a position with their official delegations.

To ensure the highest participation possible, we will send a letter to the Speaker of your Parliament asking for travel and accommodation support for up to three (3) GOPAC members. Members are also highly urged to approach national, regional and international donors over similar concerns.
