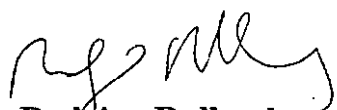
REQUERIMENTO Nº 126, DE 2012

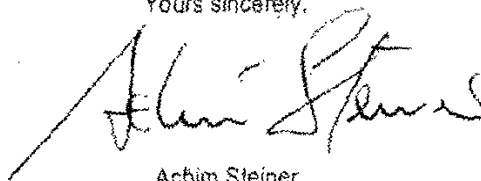
