Dear Deputy Gustavo Gayer,

As Chairman of the Global Human Rights, Global Health, and International Organizations Subcommittee, I closely follow developments in human rights. As you are aware, some of the world's leading news media have published reports of serious violations of human rights and the rule of law by officials of the government of Brazil, including the muzzling of opposition media, violations of media freedom and freedom of expression, and the persecution of critics of the government and members and supporters of political opposition parties.

On Tuesday, May 7th, at 10 a.m., I am chairing a hearing entitled: "Brazil: A Crisis of Democracy, Freedom, and Rule of Law?" The hearing, features a panel of nongovernment experts, is open to the public and I write to extend an invitation to attend to you and your colleagues in the Brazilian Senate and Chamber of Deputies listed on the enclosed attachment.

Following the hearing, we can meet for subsequent discussions as your position and responsibilities as elected officials afford you critical insights into the situation in your country and the concerns of its people. Both the hearing and discussion will usefully inform congressional oversight over U.S. foreign policy as well as potential advocacy in support of the human rights of the people of Brazil.

In my service as a U.S. Congressman, I have had the pleasure and privilege of visiting your country, knowing and working with many Brazilians and Brazilian-Americans, and remain deeply committed to strengthening the relationship between the U.S. and Brazil.
