

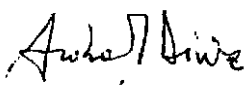


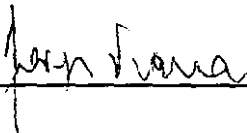

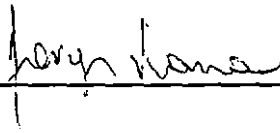
REQUERIMENTO Nº 293, DE 2011
